

**Minutes of 30<sup>th</sup> Annual Meeting  
Southern Poultry Science Society  
January 27, 2009**

- I. With 72 members present, President Audrey McElroy called the meeting to order. The first order of business was the reading of the minutes from the previous meeting on January 22, 2008. It was moved to dispense with the reading of the minutes; the motion was seconded and passed with no discussion or dissenting votes.
- II. Audit Committee chairman, Jack McReynolds, presented the report of the Audit Committee. (Attachment 1). The audit committee did not present any specific recommendations or comments.

It was moved that the report of the audit committee be accepted. The motion was seconded and passed with no discussion or dissenting votes.

- III. Executive Secretary, Bob Buresh presented the financial report for the 2008 IPSF (Attachment 2) and the financial report for the 2007-2008 fiscal year (Attachment 3).

He outlined in Attachment 2 that the expenses for the 2008 meeting reflect all of the expenses associated with the Forum, including the student luncheon, poster reception and all of the food/beverages provided during the breaks. Some of these expenses are covered by the sponsor donations and not the meeting registration, therefore a net meeting deficit of \$10,057.38 was recognized. This deficit was split between SPSS and SCAD based on the attendance percentages for the two societies.

The 2007-2008 Financial Report (Attachment 3) was reviewed. Sponsor donations for the 2008 meeting were \$19,201 (nearly the same as the \$19,426 received for the 2007 meeting). It was noted that SCAD reimbursed SPSS a total of \$1,146.54 for their portion of the costs associated with the 2008 meeting.

The topic of joint meeting registration (IPSF and IPE) was reviewed and the reasons presented. The benefit to SPSS is by allowing USPEA to conduct registration; they (USPEA) will be responsible for all meeting related expenses. Therefore, SPSS will not be receiving a bill for expenses exceeding the registration income as has been common in recent years.

It was moved that the report be accepted as presented. The motion was seconded and passed with no discussion or dissenting votes.

- IV. Resolution committee chairman Robbie Upton presented their report. (Attachment 4)

It was moved that the report be accepted as presented. The motion was seconded and passed with no discussion or dissenting votes.

- V. The Program Report was presented by 2<sup>nd</sup> VP Joe Hess. (Attachment 5).

It was moved that the report be accepted as presented. The motion was seconded and passed with no discussion or dissenting votes.

- VI. First Vice President, Hector Cervantes expressed his appreciation to the judges and presented the student awards. Each student received a certificate and check for \$250.

- VII. The presentation of the Alltech Student Research Manuscript Award was made by Kevin McBride of Alltech. The recipient was Jessica Spradley of the University of Georgia. She was awarded with a plaque and a \$500.00 check. Her advisor was A.J. Davis.

Nominations were requested from the floor. None were presented and Stonerock moved that the nominations be closed and the three unopposed officers be elected by acclamation. It was seconded. These nominees were elected by acclamation.

A ballot election was conducted of the voting members and Mike Persia was elected as 2<sup>nd</sup> Vice President.

IX. President McElroy presented the items of Old Business:

A. The only item of unfinished business was the creation of an investment plan for some of the funds of the society. This item was reported on previously as part of the financial report.

X. President McElroy called for New Business.

A. Presentation by FASS Representative Sarge Bilgili presenting the plan to rejuvenate the public policy activities of FASS in Washington, DC. The concept of the program was presented and discussed by the membership. There was some concern expressed of SPSS participating in the public policy arena. Sarge completed his presentation and moved that SPSS support the position to the amount of \$5000 per year for 3 years. This support is dependent on two items: (1) Substantial support is obtained from other participating societies, and (2) SPSS does not receive a bill from USPEA for the excess expenses related to the 2009 IPSF as outlined in the financial report. The motion was seconded and passed.

B. Executive Secretary Buresh made several comments:

1. Difficulties continued regarding the occurrence of absent oral and poster presenters. These persons will be notified that their abstracts will not be published in the Poultry Science Journal and stressed the problems created by their absence.
2. Alltech Manuscript Award letters were included in the envelopes presented to this year's presentation award winners.

XI. President McElroy made the following closing comments:

1. Abstracts for the 2010 International Poultry Scientific Forum will be due on Wednesday, October 7, 2009.
2. The next meeting of the society will be on January 25-26, 2010.
3. Registration fees will remain the same as this year, including the joint registration process.

XII. President McElroy turned the meeting over to President-elect Hector Cervantes for adjournment. It was moved and seconded. The vote was unanimous.

The Audit Committee composed of Jack McReynolds, Chairman, and Sarge Bilgili has reviewed the financial records of the Society for the operating year 2007-2008. The following comments are offered to the Society.

1. The balance in the First Security Bank of Springdale checking account (#100421000) as of October 1, 2007, was \$49,027.63. This account was closed on September 9, 2008 with a balance of \$53,294.90. These funds were split between the Wachovia checking account (#2000041956328) with \$23,294.90 and the Wachovia Money Market account (#2000041956331) with \$30,000. The balance in these two accounts as of September 30, 2008 was \$53,328.75.
2. All records were in good order. The records included receipts with check numbers and copies of the checks. All expenses were for legitimate purposes of running this organization.
3. The end of the period checking account balance was correct, based on the starting balance, income and expenses for the period.

- Thank everyone that agreed to chair a session as well as those that operated the projectors and helped with the lights. It takes a lot of people to keep a meeting on schedule.
- This year, a total of 228 abstracts, 143 oral presentations and 85 posters. 57 presentations and posters were included in the student competition. This compares to 195 presentations and posters at the 2008 meeting.
- Since U.S. Poultry & Egg Association is handling the registration, we do not get the final numbers until after the meeting; this year's registration is estimated to be 736. This is compared to 729 registered last year and 763 registered at the 2007 meeting.
